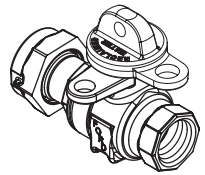


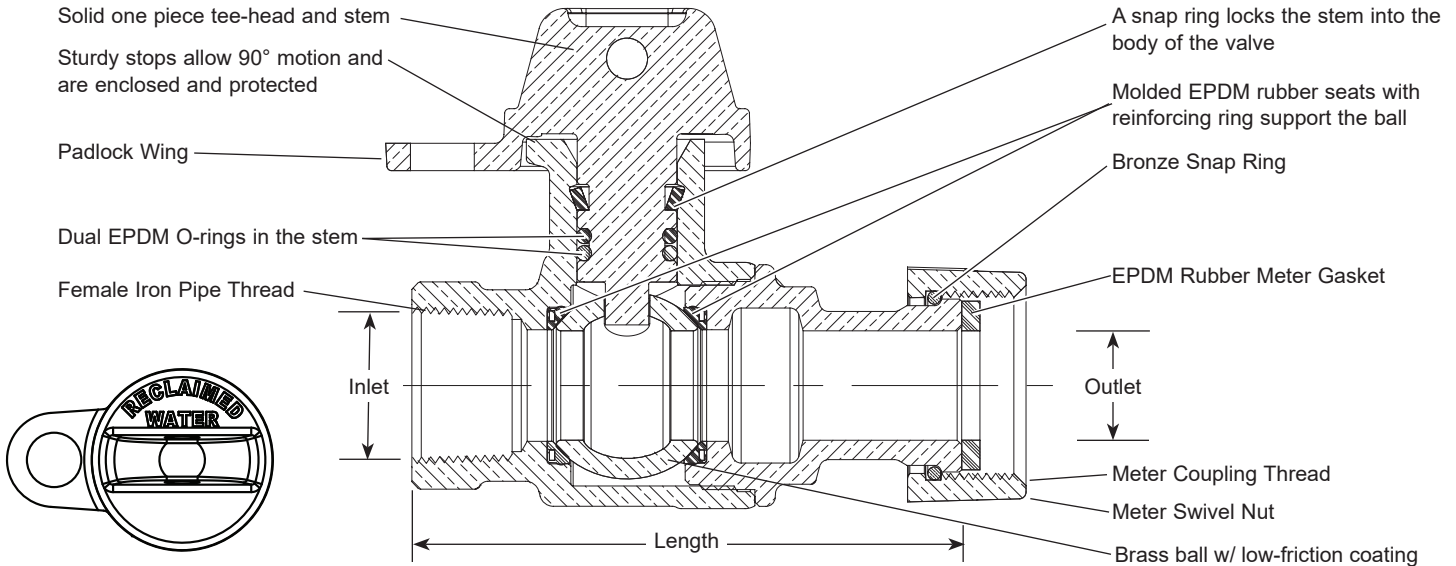

- Ends are integral or secured with adhesive to prevent unintentional disassembly
- Hole for attaching handle is provided in the tee-head
- 300 PSI working pressure
