

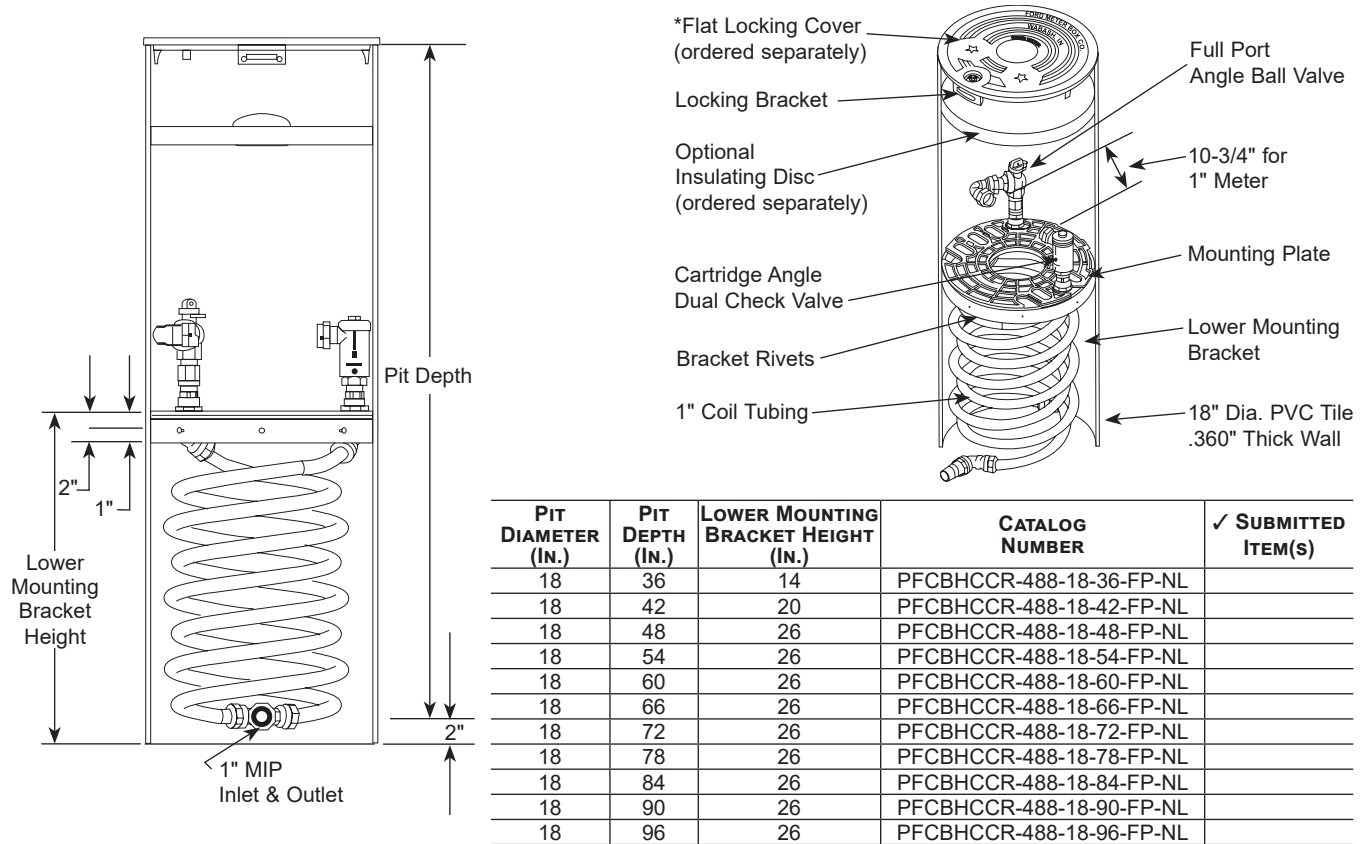

- Lightweight body is made from PVC tile, per ASTM D2241
- HDPE coil tubing, per ASTM D2737, SDR 9 CTS sized
 - Coil complies with AWWA C901
 - Coil is ANSI/NSF 61 Certified
 - Coil is rated at 250 PSIG working pressure
- Allows meter to be raised for meter access and lowered below the frost line to prevent meter and service line freeze-ups in colder climates
- Inlet and outlet valves are secured to a slotted, adjustable mounting plate
- Upper and lower mounting brackets secure the position of the mounting plate
- Male iron pipe service line connections are clearly identified for quick and easy installation
- Enhanced chlorine/chloramine resistance on check valve
- Coil pits ship with a plastic idler to maintain meter spacing and alignment during transportation and installation
- *Flat cast iron cover, per ASTM A48, Class 25 (see PPSC lids in catalog section FA, ordered separately)
- Optional: Closed-cell polyethylene foam disc provides additional freezing protection (See CCID's in catalog section FA, ordered separately)
- ASSE 1024 approved dual check valve
