






3/4" MALE IRON PIPE THREAD INLET AND OUTLET - FOR 5/8" X 3/4" METER

- · Male iron pipe service line connections are clearly identified for quick and easy installation
- Coil pits ship with a plastic idler to maintain meter spacing and alignment during transportation and installation *Flat cast iron cover, per ASTM A48, Class 25 (see PPSC lids in catalog section FA, ordered separately)
- Optional: Closed-cell polyethylene foam disc provides additional freezing protection (See CCID's in catalog section FA, ordered separately)
