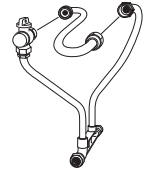


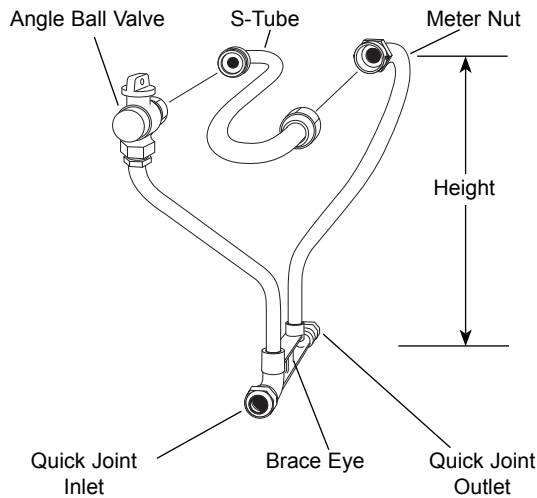

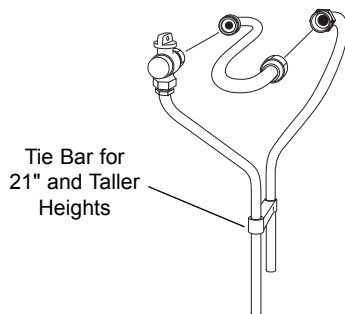

- Bracing eye is standard on all 70 Series Coppersetters
- A single Tie Bar is standard for 21"-39" Coppersetter heights; 42" and taller will require two Tie Bars (TVB74 Series)
- 1-1/8" Copper Risers provide more flow capacity
- All Ford Setters are assembled with lead-free solder
- Unless specified otherwise, Tandem Coppersetters are designed to hold a water meter in series with a pressure regulator
- Tandem Coppersetters include an "S" tube and a pair of male iron pipes by male meter thread regulator adapters for holding a pressure regulator
