



ANGLE BALL VALVE BY ANGLE BALL VALVE (5/8" X 3/4" METER)





***The Angle Ball Valve is a one-way directional valve designed for the inlet side of the meter and should not be used as a customer shut-off on the customer side of the meter.**

- Copper conforms to ASTM B75, UNS C12200
- Bracing eye is standard on all 70 Series Coppersetters
- Tie bar is standard for 18" and taller Coppersetter heights (TVBB72 Series)
- 13/16" Copper Risers provide more flow capacity
- All Ford Setters are assembled with lead-free solder
- Unless specified otherwise, Tandem Coppersetters are designed to hold a water meter in series with a pressure regulator
- Tandem Coppersetters include an "S" tube and a pair of male iron pipe by male meter thread regulator adapters for holding a pressure regulator
