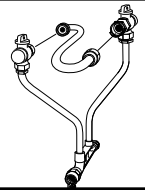


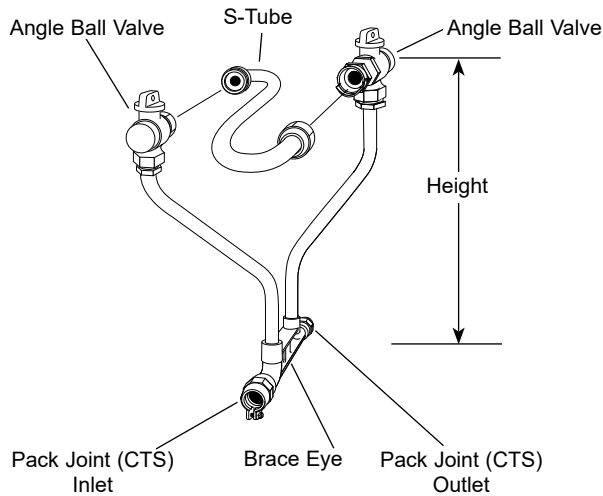

- Tandem Coppersetters include an "S" tube and a pair of male iron pipe by male meter thread regulator adapters for holding a pressure regulator
- The directional angle ball valve shall be rated at 150 PSI when used as a customer shut-off on the outlet side of the meter
