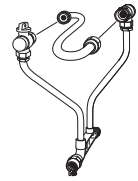


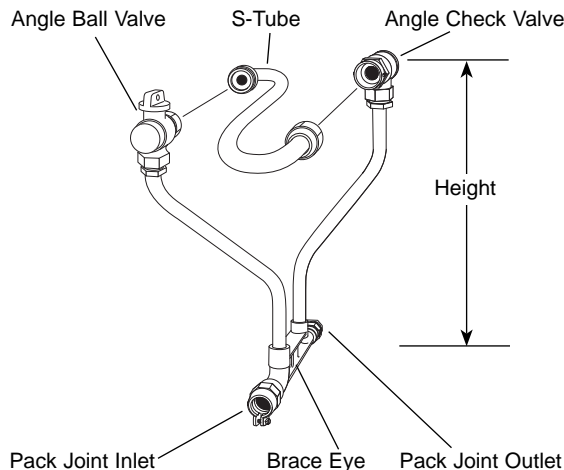

### ANGLE BALL VALVE BY ANGLE CHECK VALVE (1" METER)

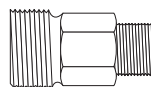

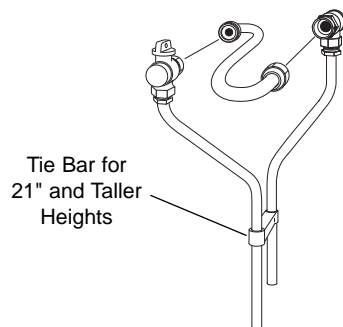

- Unless specified otherwise, Tandem Coppersetters are designed to hold a water meter in series with a pressure regulator
- Tandem Coppersetters include an "S" tube and a pair of male iron pipes by male meter thread regulator adapters for holding a pressure regulator
