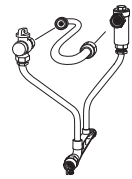


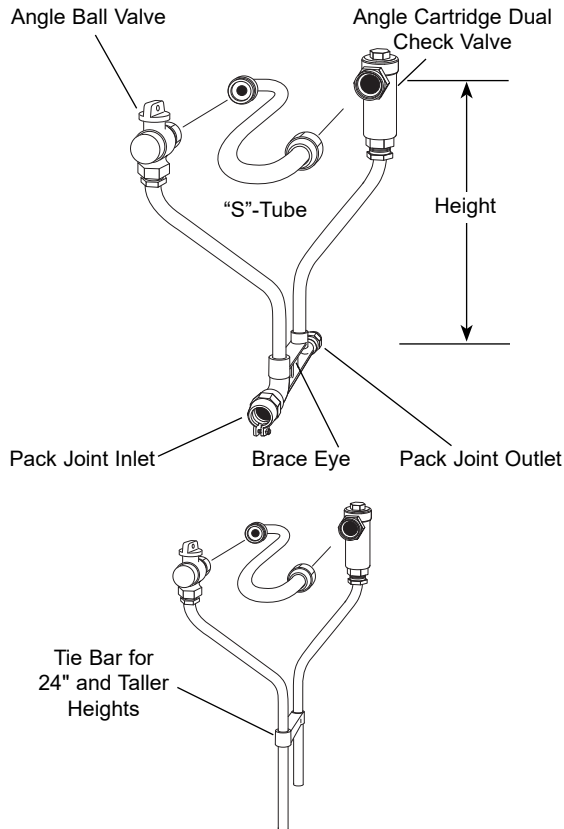

ANGLE BALL VALVE BY ANGLE CARTRIDGE DUAL CHECK VALVE (1" METER)

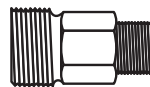
