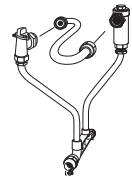


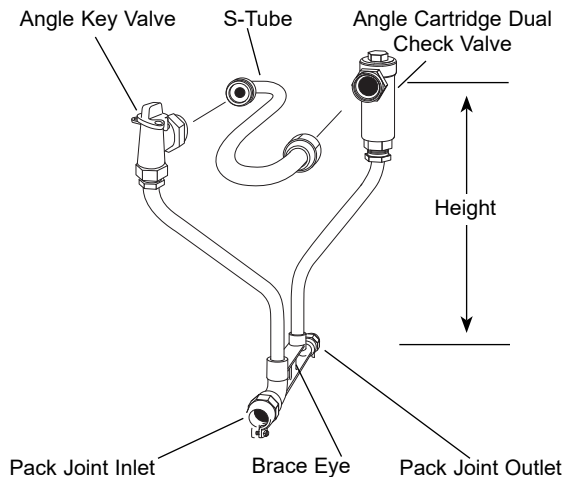

ANGLE KEY VALVE BY ANGLE CARTRIDGE DUAL CHECK VALVE (5/8" METER)

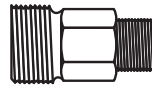

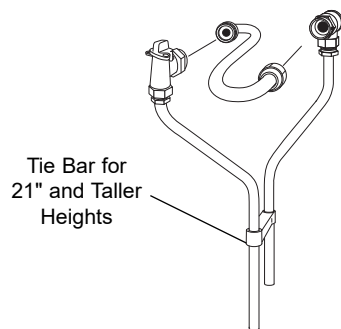
