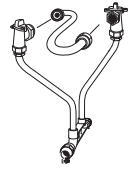


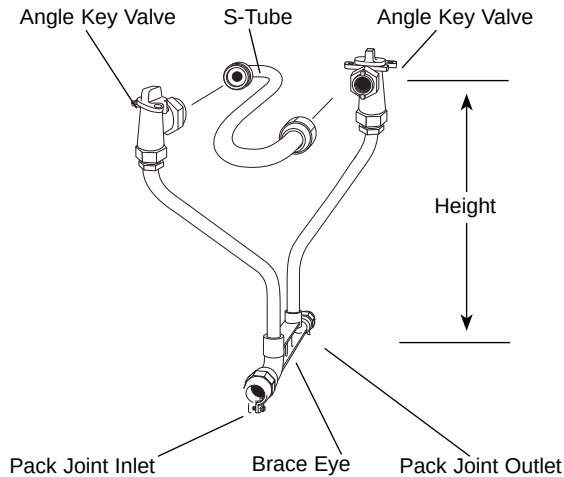

ANGLE KEY VALVE BY ANGLE KEY VALVE (5/8" X 3/4" METER)

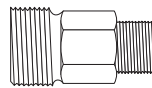

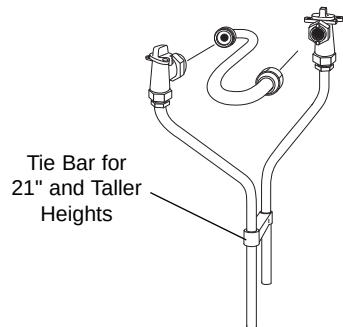
