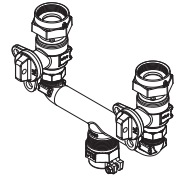
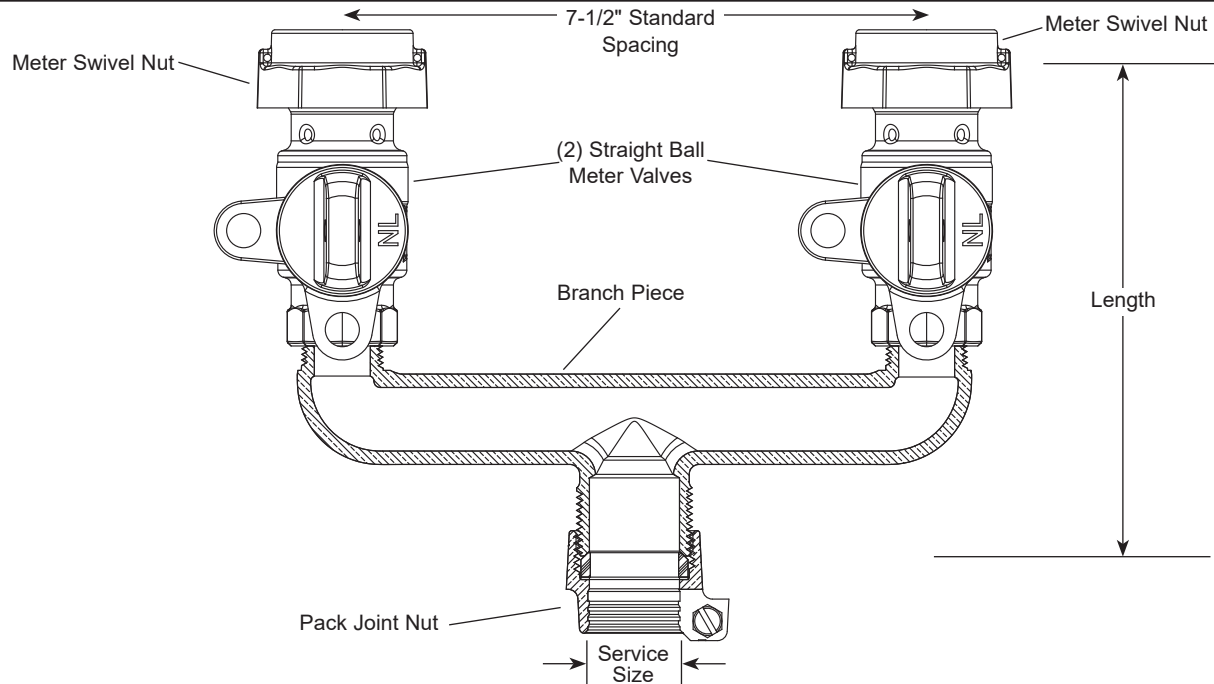

 - Meter gaskets are furnished with all branch valve assemblies
 - Meets high pressure service line requirements of AWWA Standard C800
 - Conforms to AWWA C700 for meter threads
