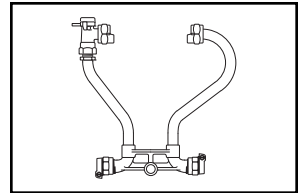


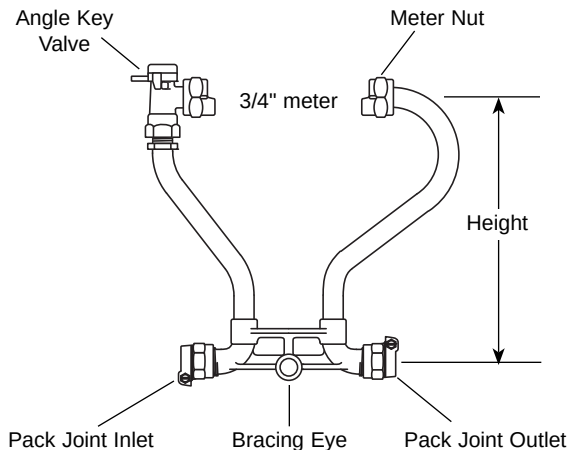

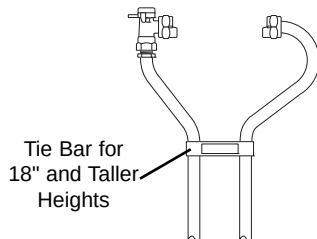
ANGLE KEY VALVE BY METER NUT (3/4" METER)

- Copper conforms to ASTM B-75, Copper Alloy #122
