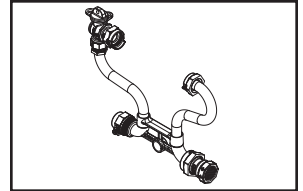


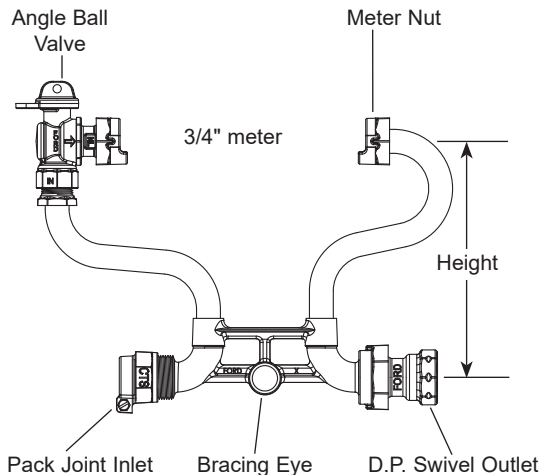

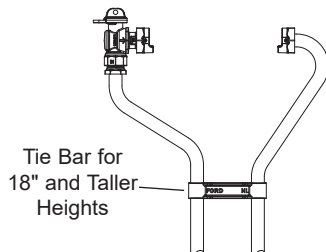

- 15/16" copper risers provide more flow capacity
