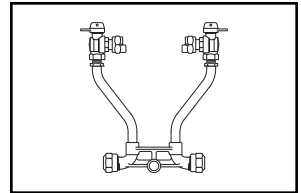


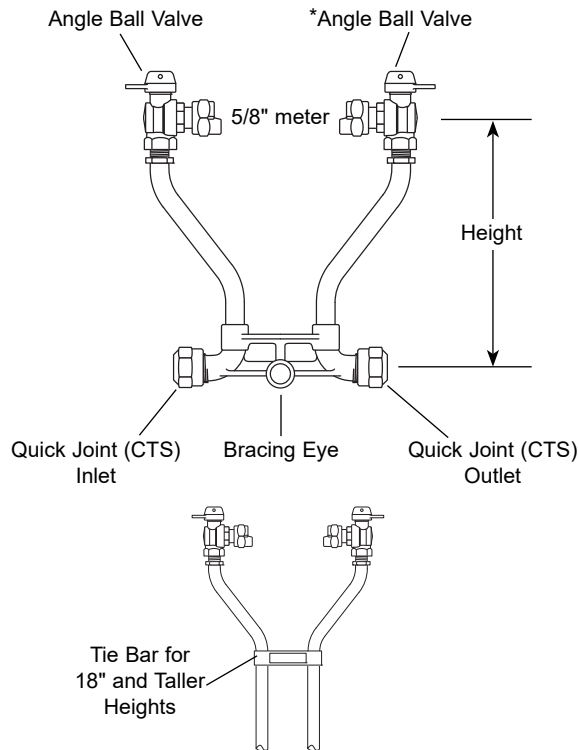

- The product has the letters "NL" cast into the main body for lead-free identification
- Brass components that do not come in contact with potable water conform to AWWA Standard C800 (ASTM B62 and ASTM B584, UNS C83600, 85-5-5-5)
- Copper conforms to ASTM B75 or B88, UNS C12200
- Saddle nuts hold the meter in place for tightening
- Bracing eye is standard on all 70 Series Coppersetters
- Tie bar is standard for 18" and taller Coppersetter heights (71 Series)
- 13/16" copper risers provide more flow capacity
- All Ford® Setters are assembled with lead-free solder
- Padlock wing standard on all angle ball or key valves
