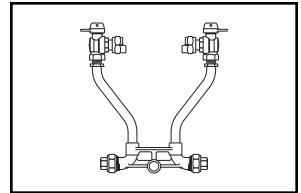


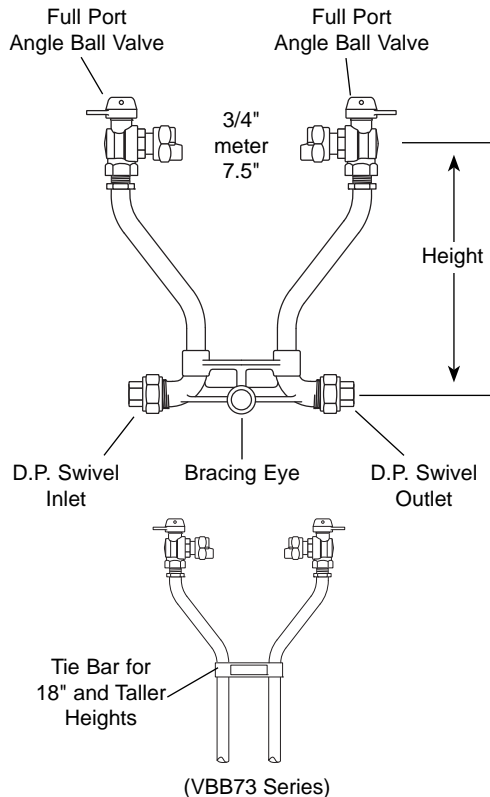

- Double Purpose Union Swivels will accommodate male iron pipe threads or flare copper
- 15/16" Copper Risers with approximately 1/16" wall thickness, provide more flow capacity
- All Ford Setters are assembled with lead-free solder
- Copper conforms to ASTM B-75, Copper Alloy #122
- The directional angle ball valve shall be rated at 150 psi when used as a customer shut-off on the outlet side of the meter
