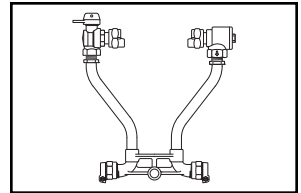


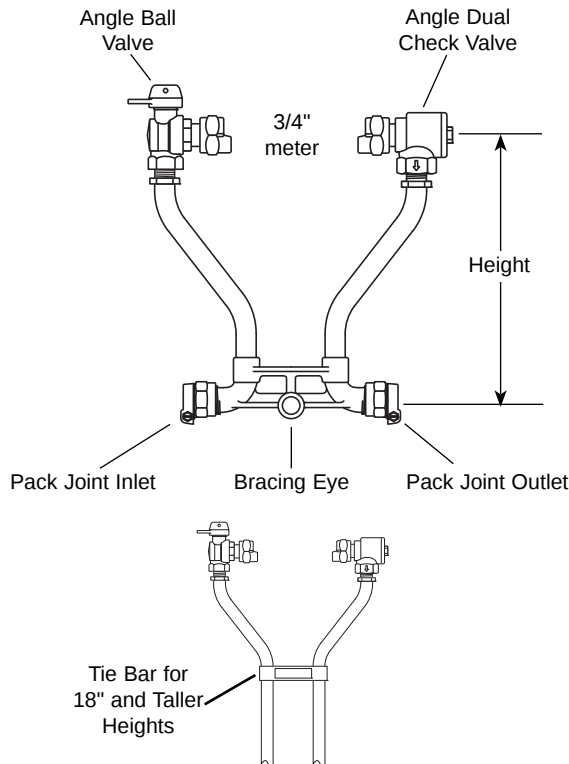

- Copper conforms to ASTM B-75, Copper Alloy #122
- ASSE 1024 approved Dual Check Valve
