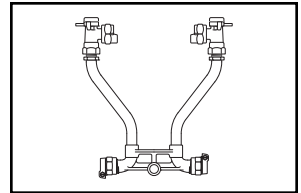


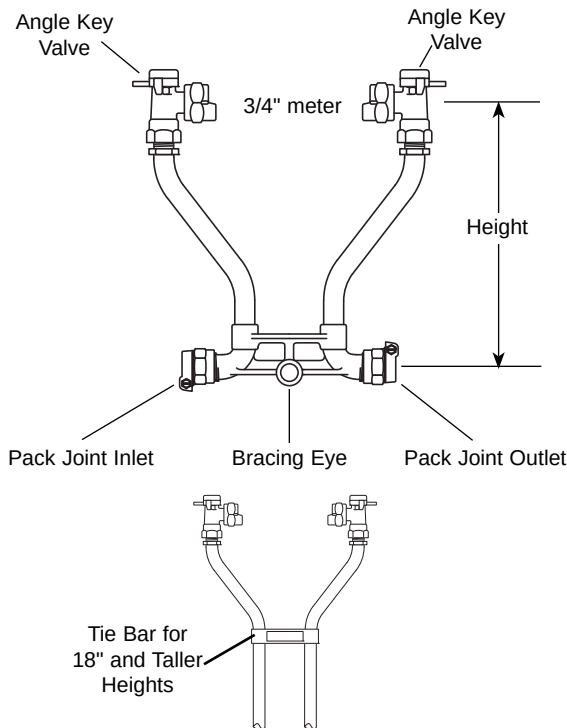

- All Ford Setters are assembled with lead-free solder
- Copper conforms to ASTM B-75, Copper Alloy #122
