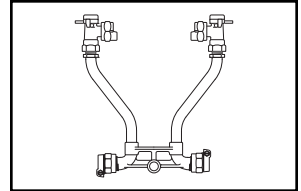


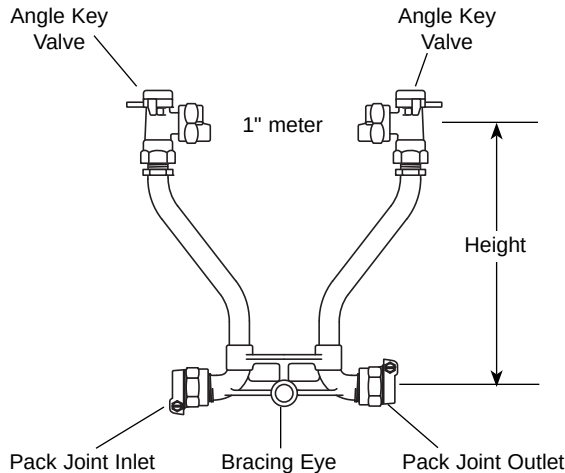

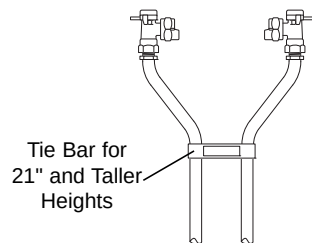
ANGLE KEY VALVE BY ANGLE KEY VALVE (1" METER)
